# GARDENS OF THE COTSWOLDS

for Heritage Circle Members of the Royal Oak Foundation







Dream of the English countryside, with gently rolling hills and picture-perfect traditional villages and you may well have a vision of The Cotswolds. Close to London and Oxford, yet still unspoiled, this sought-after area with its gorgeous gardens and royal connections is our destination for spring 2023.

Staying at a luxurious historic inn in the charming village of Broadway, we will be shown famous and influential gardens such as Hidcote, now in the care of the National Trust and neighbouring Kiftsgate, with its monumental rambling rose. We will also have special access to a number of secret private gardens where owners have created their own horticultural paradise. We can compare the design and planting of Tudor knot gardens, cottage gardens, organic gardens and walled gardens and admire features from romantic temples and grottoes to imaginative topiary and striking contemporary sculpture. A crowning highlight, subject to confirmation, will be a visit to Highgrove, the garden of HM The King, a pioneer of organic gardening.

Your tour will be accompanied by art historian and garden lover Rosalind Malandrinos who lives in the Cotswolds and is a guide at Sudeley Castle.



# Day 1 / Monday, May 29 Travel To Broadway

## **MORNING**

Depart from London Victoria for Broadway, transfer by private coach to The Lygon Arms.

## **AFTERNOON**

After a light lunch in the hotel, explore the attractive village of Broadway often referred to as the "Jewel of the Cotswolds". The village lies beneath Fish Hill on the Cotswold escarpment. The "broad way" is the wide grass-fringed main street, centred on the Green, which is lined with red chestnut trees and picturesque honey-coloured Cotswold limestone buildings. The village has an interesting artistic heritage and is known for its association with the Arts and Crafts movement. The wide High Street is lined with a wide variety of shops and cafes, many housed in listed buildings.

## **EVENING**

Welcome drinks and dinner in a private room at the hotel.

Overnight at The Lygon Arms.



## Day 2 / Tuesday, May 30 Hidcote & Kiftsgate

## **MORNING**

Visit the garden at Hidcote Manor (National Trust) one of England's great gardens, and one of the most influential of the 20th century. Major Lawrence Johnston, a self-taught gardener, created this Arts and Crafts masterpiece from fields in the early 1900s, when he and his mother settled in Britain from America.

Lunch Independently at Hidcote Café.

## **AFTERNOON**

Continue to nearby Kiftsgate Court Gardens. Just after the Great War, Heather Muir and her husband bought Kiftsgate and her long friendship with neighbour Lawrence Johnson undoubtedly inspired the creation of the garden. The friends

gardened in the same way, with structured design, a wide choice of plants and exemplary use of color. Mrs Muir's daughter, Diany Binny, and grand daughter, Anne Chambers, have enhanced the garden over the years however Heather's original ideas and sense of color guide their planting.

## **EVENING**

Return to the hotel for time at leisure.

Dinner privately in a local restaurant.

Overnight at The Lygon Arms.



## Day 3 / Wednesday, May 31 Sezincote, Rockcliffe & Upton Wold

## **MORNING**

After breakfast leave the hotel by coach for a privately guided visit of Sezincote house and garden. This unique 18th century house situated at the heart of a traditional, family-run estate of rolling Cotswold countryside appears as a 200-year-old Mogul Indian palace, set in a romantic landscape of temples, grottoes, waterfalls and canals reminiscent of the Taj Mahal.

Continue to Daylesford Organic Farm for lunch.

## **AFTERNOON**

Leave for Rockcliffe Gardens, Lower Swell. This large traditional English garden of eight acres includes beautiful color themed herbaceous borders, a rose terrace, a traditional walled kitchen garden and a pathway of topiary birds.

## **EVENING**

Leave early evening for Upton Wold for a private guided tour of the wonderful gardens followed by a private dinner. The gardens are architecturally and imaginatively laid out around the 17th century Cotswold stone house with magnificent views.

Overnight at The Lygon Arms



# Day 4 / Thursday, June 1 Highgrove, Frampton Court & Sudeley Castle

## **MORNING**

Leave by coach for Highgrove.

Visit Highgrove Gardens for a tour of the garden of the family residence of Their Majesties The King and The Queen Consort (subject to confirmation of opening dates in 2023). Since 1980 the former Prince of Wales has been devoted to creating one of the most inspired gardens in Europe. The garden and surrounding land have been managed to the organic and sustainable principles that the King has for so long championed.

Lunch at The Orchard Restaurant at Highgrove.

## **AFTERNOON**

Leave for Frampton-on-Severn, the Vale of Berkeley. On arrival at Frampton Court Estate, visit Frampton Manor garden followed by the formal garden at Frampton Court. The Manor of Frampton has been in the Clifford family for almost one thousand years. Comprising of the timber-framed 16th century Manor house, surrounded by cottage style gardens and the early 18th-century Palladian Frampton Court with its historic gothic Orangery, Dutch canal and parkland.

## **EVENING**

Early evening drive to historic Winchcombe for a private visit to Sudeley Castle & Gardens. Best known as the home of Queen Katherine Parr, the last and surviving wife of King Henry VIII. Surrounding the beautiful Castle are 14 acres of stunning award-winning gardens including an intricate Tudor Knot garden, a collection of English roses and double yew hedges. Dinner privately at the Castle.

Overnight at The Lygon Arms



# Day 5 / Friday, June 2 Eastleach House, The Old Rectory & Westwell

## **MORNING**

After breakfast leave the hotel by coach to visit Eastleach House gardens. Perched on the hill above the village, the attractive Cotswold stone house is surrounded by a 14-acre garden of many different parts. From the South Lawn there are views of the Marlborough Downs on one side, whilst on the other there is a Rill Garden and Walled Garden which is planted with yew hedges dividing the space into rooms.

Continue to lunch privately at Quenington Manor, The Old Rectory followed by a garden visit. Situated on the banks of the River Coln, this is an organic garden of variety. With mature trees, large vegetable gardens, herbaceous, shade, pool and bog gardens. A charming contemporary dovecot/library is built alongside the river, and various contemporary sculptures are found in the grounds.

## **AFTERNOON**

After lunch continue to Westwell to a nearby private garden by kind arrangement with the owners. The late Mrs Anthea Gibson was one of England's foremost landscape gardeners and the garden at her home was her masterpiece. The Tudor manor house, which Mr and Mrs Gibson bought in 1979, is surrounded by a seven-acre walled garden. Mrs Gibson transformed the garden within its architectural framework and focused upon the use of water in both traditional and more innovative ways. This beautiful garden also has unusual features such as a twin rill, moonlight garden, paddy field and mount.

## **EVENING**

Return to the hotel.

Private farewell dinner at the hotel.

## **MORNING**

Transfer by coach (with luggage) to London Victoria.

#### **MAKING A BOOKING**

Please complete the registration form and forward it to The Royal Oak Foundation, together with your non-refundable deposit made payable to Royal Oak Foundation. If you are booking less than 10 weeks prior to departure, the full cost of the tour is payable.

On receipt of your registration form and deposit, The Royal Oak will confirm your booking in writing, then approximately 12 weeks prior to departure send you a final invoice, which will reflect any applicable surcharges due, together with further information relevant to the tour. Invoices must be paid no less than 10 weeks prior to departure (or immediately if bookings are made within 10 weeks of departure), otherwise we reserve the right to treat the booking as cancelled and apply cancellation conditions as set out below.

#### FITNESS TO TRAVEL

While we do not impose any age limitations on joining a tour, participants must be reasonably fit and able to cope with its specific demands, specially where sustained periods of sightseeing and walking are involved.

If you are in any doubt as to the suitability of a tour, please make this known to us before you book and we will advise you accordingly. The Royal Oak Foundation reserves the right to decline a reservation without necessarily giving a reason.

The tour organiser, in consultation with the tour Host/Representative, has the right to disqualify any client at any time during the course of a tour, if considered necessary for the medical wellbeing or safety of the individual or the client's actions are materially affecting the enjoyment of the tour for the remainder of the group. Any decision with regard to reimbursement for any part of the tour not completed will be decided by the Managing Director of The Ultimate Travel Company Ltd. and the tour organiser.

### CANCELLATION

You or a member of your party may cancel their participation on the tour provided that the cancellation is communicated in writing and by the person who signed the booking form. The deposit is non-refundable. After the balance has been paid, The Ultimate Travel Company Ltd. will charge as follows:
