Dear Royal Oak Community:

On behalf of the Royal Oak Board of Directors and staff, we are pleased to present our annual report for the fiscal year ending June 30, 2024.

Royal Oak finished another successful year with membership continuing to grow. Programs, which are a significant factor in membership growth, offered virtual lectures while also hosting live events in New York and Philadelphia, and returning to Chicago. Online and in-person events are a significant factor for attracting new members and engaging with current members.

Our two-year National Trust appeal for the Bath Assembly Rooms began in January 2023, and will conclude in December 2024, with a goal of raising \$1,000,000 toward the total project. As of June 2024, we have raised over \$900,000. Funds raised by Royal Oak will be used to restore the grand entrance and ballroom by creating a new Georgian-inspired staircase, re-gilding the mirrors, marbling to columns, and restoration of the five chandeliers.

Other significant grants to the National Trust funded by members totaled over \$700,000, including \$480,000 for Munstead Wood, \$70,000 for Trelissick, and \$44,000 for the Lake District. These generous donations ensure that we continue to fulfill our mission of raising awareness and support for the National Trust.

The annual benefit dinner was held in New York City where our distinguished speaker Robert Sackville-West, Lord Sackville spoke about the work that has been undertaken to restore his ancestral home, Knole, in Kent. He highlighted work funded by the Royal Oak Foundation to conserve a number of significant objects from various National Trust properties, which work was done in the Royal Oak Foundation Conservation Studio at Knole.

Heritage Circle members had the opportunity to travel on two international trips designed specifically for these members. On the first of these trips in October 2023 we traveled to Florence to complete the final stage of our three-part journey to learn about the Italian influence on English design and architecture. Members explored the art of the Uffizi, the Bargetto Museum and Sante Croce, and enjoyed a visit with dinner to the privately owned Palazzo Gondi.

On the second of our international trips which took place in the spring of 2024, our Heritage Circle members went to Scotland where they explored houses and gardens in Edinburgh, East Lothian and Fife. Highlights of the trip included a walking tour of Edinburgh's New Town and Old Town and a stop at Greywalls to appreciate the results of the collaboration between the architect Edwin Lutyens and the gardener Gertude Jekyll.

The fiscal year ended with net assets rising by \$1,500,000 thanks to an increase in higher level membership, and generous donations to our annual fund.

We want to thank our members for their continued support of the National Trust and The Royal Oak Foundation and look forward to seeing you in the coming year.


Royal Oak's mission is to raise awareness and advance the work of the National Trust of England, Wales, and Northern Ireland by inspiring support from the United States for the Trust's efforts to preserve and protect historic places and spaces—forever, for everyone.

Essential to the success of that mission is the enduring participation of you, our members. This fiscal year, in the wake of the COVID pandemic, we saw a steady rise in the number of travelers to the UK. As a result, new memberships generated a 14.5% increase in revenue compared to the previous fiscal year.

National Trust staff and volunteers greet many American visitors each year, and encourage those who are not already members of Royal Oak to join our community of Anglophiles. We call this special group JIUK (Joined in the UK). Membership revenue from this group increased 25% over the previous fiscal year.

We are encouraged that travel is once again on the rise and that the National Trust is graciously welcoming visitors, including the Royal Oak community. Our members regularly share with us stories of their wonderful experiences while visiting these historic sites. We hope you look forward to returning to Great Britain and all of the treasures of the National Trust. Thank you so much for your support.

A VITAL SOURCE OF SUPPORT FOR THE NATIONAL TRUST AND ROYAL OAK

The Heritage Circle was created for individuals who wish to show their leadership and support of Royal Oak at the highest level of membership. Heritage Circle members enjoy special behind-the-scenes access to heritage sites, private events, and curated tours.

One popular tour benefit offers members complimentary access to Study Day which occurs each fall in the U.K. In 2023, members visited Stansted Park, an Edwardian country house set within the South Downs National Park, and Uppark House a 17th-century house now in the care of the National Trust. On the evening before Study Day, Patron and Guardian members enjoyed dinner at the Travellers Club in London.

Another attractive benefit is eligibility to participate in our spring Houses & Gardens Tour as well as the fall Art & Architecture tour.


In the fall of 2023, our annual Art & Architecture tour took us to Florence, the cradle of the Renaissance, where participants learned about the influence of the Medici family. This was the third and final leg of our series "The Influence of Italian Architecture on the English Country House." We had previously visited Rome and Venice.

In the spring of 2024, Heritage Circle members had the opportunity to visit magnificent houses and gardens of Scotland, using the 5-star Balmoral hotel in Edinburgh as their base to explore the countryside. They visited a wide variety of Scottish gardens in Edinburgh, the historic kingdom of Fife, and the scenic Scottish Borders and coastal East Lothian which lies south of the Firth of Forth.

On our domestic spring trip to Pasadena, California, Heritage Circle members went on a private tour of the Huntington Library's British art collection and botanical garden. They also had a private tour of Gambling House, and a tour and reception of a private home with a renowned 9-acre garden, all punctuated with gourmet dining.

Income from Heritage Circle Membership dues continues to increase with a 10% rise this year compared to the prior year, and the addition of several new Patron members. Total revenue since the inception of this premium member category in 2006 is more than \$2.4 million.

We are deeply grateful for the philanthropic leadership you continue to demonstrate.



NATIONAL TRUST APPEAL

THE BATH ASSEMBLY ROOMS

Our 2023-2024 appeal for the Bath Assembly Rooms will conclude in December 2024.

Royal Oak members and friends have so far contributed over \$900,000 to support the National Trust in restoring the grandeur and elegance of the Bath Assembly Rooms.



Bath is one of the UK's most loved and visited cities. Turn any corner across this UNESCO city of historical importance and you are surrounded by sites of breathtaking beauty and historical significance, from the Royal Crescent to the Roman Baths.

During the Georgian era, the famous and prestigious Assembly Rooms in the city of Bath were at the heart of fashionable society. Designed by John Wood the Younger, when they were completed in 1771, they were described as "the most noble and elegant of any in the kingdom."

Bath Assembly Rooms were built for the delight of the polite society that developed during the 18th century, when the ceremonials of rank were broken down, the nobility mixed with the gentry and people passed their time together in agreeable conversation against a backdrop of strolling, dancing, playing cards and taking tea. The American Declaration of Independence, the First Fleet's departure to Australia, and the French Revolution would all have been discussed and debated within the walls of the Assembly Rooms.

The Grade I listed Assembly Rooms have been owned by the National Trust since 1931 and managed by the local authority since 1937. The council's lease ended in 2023 creating the perfect moment for the National Trust to work with a range of partners to create a new future for this special place and restore the historical integrity of the Assembly Rooms.

Royal Oak funds will be used to build a new Georgianinspired staircase; re-gilding of the mirrors; marbling of the columns; new front doors; new light wells; re-candling and re-wiring of the five chandeliers; new floorboards; installation of new vapor fireplaces; and new double-glazed windows.

The Assembly Rooms will allow contemporary visitors to immerse themselves in an evocation of a Georgian ball and explore histories of the time.





PROGRAMS & LECTURES

EDUCATIONAL PROGRAMS JULY 2023-JUNE 2024

The Royal Oak Foundation's humanities programs form a vital part of our mission to foster a deeper appreciation for Anglo-American heritage and raise funds for the British National Trust (NT). By engaging U.S. members, we aim to raise awareness of the NT's outstanding historic portfolio and gather support for its critical historic preservation initiatives. Since 1974, Royal Oak has hosted public lectures featuring respected historians, scholars, and best-selling authors who explore topics in British art, architecture, design, social history, literature, and garden design.

From July 2023 through June 2024, the Foundation presented 43 events, reaching approximately 4,381 attendees. Our offerings included 13 online-only lectures and 9 online tours, which were also available for "rental" replays. These online programs continue to engage audiences we could not previously reach, promoting both member engagement and broader public interest. We also hosted 14 in-person lectures across three cities and conducted seven in-person tours.

Royal Oak's in-person lectures took place in New York City, Philadelphia, and Chicago, with most recorded for later online viewing. New York and Chicago programs featured John Goodall, Country Life's Architectural Editor, who presented insights from his new Rizzoli book on the beauty of the British countryside, including NT landscapes. In Philadelphia, Robert Sackville-West, 7th Baron Sackville, shared the history of his home, Knole—a remarkable NT "calendar house."

In New York, historian Emily Evans Eerdmans discussed the late American designer Mario Buatta, the "Prince of Chintz," showcasing his never-beforeseen archives and explaining Buatta's adaptations of the English country house style. Writer Patrick Monahan also captivated NYC attendees with his exploration of Noël Coward's homes around the world, sharing stories about Coward's incredible parties and illustrious guests.

Online-only lectures offered further study of England's history, including a journey through great English country houses such as Wilton, an exploration of Midlands treasure houses, and a look at the Industrial Revolution's impact on Shropshire estates. Adrian Tinniswood, OBE, talked about NT masterpieces' Standen and Wightwick Manor to show how both exemplified the construction and craftsmanship in the English Arts & Crafts movement.

We were thrilled to present a digital lecture on Gertrude Jekyll's Grade I-listed home, Munstead Wood, following its recent acquisition by the NT. Over 250 attendees enjoyed hearing from the NT Head of Gardens about this addition to the NT's portfolio of landscapes, while historian Judith Tankard discussed Jekyll's original garden designs.

As part of our Annual Appeal supporting the NT's Bath Assembly Rooms restoration, ROF hosted an in-person talk exploring Jane Austen's love for Bath as depicted in her novels. Historian Ian Cox examined Bath as a popular visitor and social destination in the Georgian era, discussing period health treatments and explaining the practice of "taking the waters."

Royal Oak members were invited to a complimentary lecture celebrating 300 years of Joshua Reynolds' works in the NT collection, presented by NT Senior Curator of Pictures and Sculpture John Chu. Another free-to-members event featured the architectural team leading the restoration of Bath's Assembly Rooms discussing their plans and historic antecedents.

Our digital tours brought "armchair travelers" to the Welsh coastline, Dumfriesshire, Scotland, as well as to London to discover London's Chelsea area and peek at the city's beloved Underground Tube system. 'Tales on Tap' uncovered the stories behind some of London's beloved drinking establishments and highlighted the significance of pubs, which are woven into the fabric of London's cultural history.

Royal Oak's in-person walking tours continue to draw members nationwide, especially for our popular Art Deco excursions. Many also traveled to join our private tours of The Morgan Library's Beatrix Potter exhibition, showcasing NT objects and illustrations. Members were digitally taken into the Victorian era to journey to the suburban cemeteries outside of London (The Magnificent Seven) that functioned as public parks. We dovetailed our English digital event with an in-person tour of the 19th century Green-Wood Cemetery in Brooklyn.

Programs' feedback remains enthusiastic, with members appreciating the convenience of digital programs and enjoying the expansion of our in-person lectures to more U.S. cities. We are excited to continue our return to more lecture cities in 2025.




EXPENSES


